# Agreement

## **Event Timing**

- Set-up: 8:00 am 9:45 am
- Tear down: 3:00 pm 4:00 pm (no earlier than 3:00 pm)

### **Event Space**

- FOTRGZ supplies one six-foot table and two chairs (additional chairs available w/advance request)
- The exhibitor may bring a tent. Tents must be framed and supported by weights, not staked.
- Drive-in unloading is available by advance request ONLY otherwise, please ensure you have a wagon to transport your exhibit booth materials from the unloading zone of the parking lot into the zoo.
- 1. The event will be held rain or shine. We consider this application as a commitment to the zoo and this event.
- 2. Set-up times for *drive-in unloading* will be assigned and will be strictly adhered to. Exhibitor must unload all materials that need to be transported by vehicle at the assigned set-up time.
- 3. If the Exhibitor misses an assigned drive-in set-up time, they will not be allowed to bring trucks or trailers into their assigned booth location.
- 4. The Exhibitor is expressly prohibited from selling, subletting, assigning, and transferring its booth space to another party. Any such sale, sublet, transfer, or assignment shall be deemed a cancellation of the Exhibitors registration.
- 5. The Exhibitor must be selling a tangible item or service (i.e. Face Painting, Popcorn, T-Shirts). All individuals and or organizations soliciting names, or advertising their business or services are considered sponsors and are not covered under the exhibitor agreement.
- 6. The Zoo reserves the right to choose all vendors. The decision will be final. Any Exhibitors not granted participation rights will be notified immediately.
- 7. Except for those being used as a booth, all trailers and trucks must be driven off site by the end of the Exhibitor's assigned set-up time. No vehicles or trailers are allowed at the booth site.
- 8. All Exhibitors are required to park cars, trucks, and trailers not serving as a stall/booth at the Main lot.
- 9. Exhibitor is responsible for all labor for and at his booth locations, including setup and teardown.
- 10. Exhibitor is required to take reasonable care to avoid damaging Zoo property in setting up and tearing down.
- 11. Exhibitor shall operate and maintain booth activity during the event times.
- 12. All signs and banners must be contained inside the Exhibitor's tent.
- 13. Exhibitor agrees to pay the \$50.00 exhibitor fee as a donation to the zoo for being allowed to execute sales on zoo property.
