Agreement

1. All set-up times will be the Friday of exhibition weekend between **4:00pm** and **5:00pm**.
2. No Exhibitor may begin teardown before **8:00pm** on Saturday of Exhibition. On the day of the event all Exhibitors must complete teardown by **9:00pm**.
3. We ask that all exhibitors provide their own 10x10 pop-up tent. *Please inform coordinators if you are unable to provide a tent.* Exhibitor must supply additional equipment if required, for example: 10x10 tents, extension cords, linens, pens, paper, photocopies or av equipment.
4. The event will be held rain, snow or shine. We consider this application as a commitment to the zoo and this event.
5. Tents must be framed and supported by weights, not staked.
6. Set-up times for drive-in unloading will be assigned to each Exhibitor by the Event Coordinator and will be strictly adhered to. Exhibitor must unload all materials that need to be transported by vehicle at the assigned set-up time.
7. In the event Exhibitor misses assigned set-up time, they will not be allowed to bring trucks or trailers into their assigned booth location.
8. The Exhibitor must be selling a tangible item or service (i.e. Face Painting, Popcorn, T-Shirts). All individuals and or organizations soliciting names, or advertising their business or services are considered sponsors and are not covered under the exhibitor agreement
9. The Exhibitor is expressly prohibited from selling, subletting, assigning, and transferring its booth space to another party. Any such sale, sublet, transfer, or assignment shall be deemed a cancellation of Exhibitors registration.
10. The Zoo reserves the right to choose all vendors. The decision will be final any Exhibitors not granted participation rights will be notified immediately.
11. Except for those being used as a booth, all trailers and trucks must be driven off site by the end of the Exhibitor's assigned set-up time. No vehicles or trailers are allowed at the booth site.
12. All Exhibitors are required to park cars, trucks, and trailers not serving as a stall/booth at the Main lot.
13. Exhibitor is responsible for all labor for and at their booth locations, including setup and teardown.
14. Exhibitor is required to take reasonable care to avoid damaging Zoo property in setting up and tearing down.
15. Exhibitor shall operate and maintain booth activity during the event times.
16. All signs and banners must be contained inside the Exhibitor's tent.
17. Exhibitor agrees to pay the exhibitor fee as a donation to the zoo for being allowed to execute sales on zoo property.
18. All VENDORS must provide FOTZ proof of commercial general liability insurance on an "occurrence" basis with liability limits in the amounts of \$1,000,000.00 per occurrence covering personal injury, bodily injury and property damage; list as additional insured, Rosamond Gifford Zoo and FOTZ.
