Agreement

1. All set-up times will begin **April 26 from 8:30am-9:15am**
2. No Exhibitor may begin teardown before **3:00pm**. On the day of the event all Exhibitors must complete teardown by **4:00pm**.
3. Exhibitor booths will consist of one six foot table with linen and two chairs. Exhibitor must supply additional equipment if required, for example: extension cords, pens, paper, photo copies or av equipment.
4. The event will be held rain or shine. We consider this application as a commitment to the zoo and this event.
5. Tents must be framed and supported by weights, not staked.
6. All materials must be hand carted to exhibition space. Exhibitors will not be able to drive up to exhibitor space.
7. The Exhibitor is expressly prohibited from selling, subletting, assigning, and transferring its booth space to another party. Any such sale, sublet, transfer, or assignment shall be deemed a cancellation of Exhibitors registration.
8. The Exhibitor must be selling a tangible item or service (i.e. Face Painting, Popcorn, T-Shirts). All individuals and or organizations soliciting names, or advertising their business or services are considered sponsors and are not covered under the exhibitor agreement
9. The Zoo reserves the right to choose all vendors. The decision will be final any Exhibitors not granted participation rights will be notified immediately.
10. Exhibitor is responsible for all labor for and at his booth locations, including setup and teardown.
11. Exhibitor is required to take reasonable care to avoid damaging Zoo property in setting up and tearing down.
12. Exhibitor shall operate and maintain booth activity during the event times.
13. All signs and banners must be contained inside the Exhibitor's tent.
14. Exhibitor agrees to pay the \$50.00 exhibitor fee as a donation to the zoo for being allowed to execute sales on zoo property
