# Agreement

- 1. Set-up time will be between 8:45am and 9:30am.
- 2. No Exhibitor may begin teardown before **3:00pm**. On the day of the event all Exhibitors must complete teardown by **4:00pm**.
- 3. Exhibitor must supply all equipment necessary. Exhibitor may request up to two chairs and one six foot table. Requests must be submitted one week prior to the date of attendance.
- 4. The event will be held rain or shine. We consider this application as a commitment to the zoo and this event.
- 5. Tents must be framed and supported by weights, not staked.
- 6. Exhibitor must unload all materials at the assigned set-up time.
- 7. The Exhibitor is expressly prohibited from selling, subletting, assigning, and transferring its booth space to another party. Any such sale, sublet, transfer, or assignment shall be deemed a cancellation of Exhibitors registration.
- 8. The Exhibitor must be selling a tangible item or service (i.e. Face Painting, Popcorn, T-Shirts). All individuals and/ or organizations soliciting names, or advertising their business or services are considered sponsors and are not covered under the exhibitor agreement.
- 9. The Zoo reserves the right to choose all vendors. The decision will be final any Exhibitors not granted participation rights will be notified immediately.
- 10. Except for those being used as a booth, no vehicles or trailers are allowed at the booth site.
- 11. All Exhibitors are required to park cars, trucks, and trailers not serving as a stall/booth at the Main lot.
- 12. Exhibitor is responsible for all labor for and at their booth locations, including setup and teardown.
- 13. Exhibitor is required to take reasonable care to avoid damaging Zoo property in setting up and tearing down.
- 14. Exhibitor shall operate and maintain booth activity during the event times.
- 15. All signs and banners must be contained inside the Exhibitor's tent.
- 16. Exhibitor agrees to pay the \$50.00 exhibitor fee as a donation to the zoo for being allowed to execute sales on zoo property.
