#### Agreement

- 1. All set-up times will be April 20 from 8-10 a.m.
- 2. No Exhibitor may begin teardown before **3 p.m**. On the day of the event all Exhibitors must complete teardown by **4:30 p.m**.
- 3. Exhibitor booths will consist of one six foot table with linen and two chairs. Exhibitor must supply additional equipment if required, for example: extension cords, pens, paper, photo copies or av equipment.
- 4. The event will be held rain or shine. We consider this application as a commitment to the zoo and this event.
- 5. Tents must be framed and supported by weights, not staked.
- 6. Please contact Olivia Fottrell to schedule an arrival and set-up time between 8-10 a.m. no later than April 17
- 7. All materials must be hand carted to exhibition space. Exhibitors will not be able to drive up to exhibitor space.
- 8. The Exhibitor is expressly prohibited from selling, subletting, assigning, and transferring its booth space to another party. Any such sale, sublet, transfer, or assignment shall be deemed a cancellation of Exhibitors registration.
- 9. The Exhibitor must be selling a tangible item or service (i.e. Face Painting, Popcorn, T-Shirts). All individuals and or organizations soliciting names, or advertising their business or services are considered sponsors and are not covered under the exhibitor agreement
- 10. The Zoo reserves the right to choose all vendors. The decision will be final any Exhibitors not granted participation rights will be notified immediately.
- 11. Exhibitor is responsible for all labor for and at his booth locations, including setup and teardown.
- 12. Exhibitor is required to take reasonable care to avoid damaging Zoo property in setting up and tearing down.
- 13. Exhibitor shall operate and maintain booth activity during the event times.
- 14. All signs and banners must be contained inside the Exhibitor's tent.
- 15. Exhibitor agrees to pay the \$50 exhibitor fee as a donation to the zoo for being allowed to execute sales on zoo property
